Additional Test Administration Added

The TPED Board is excited to announce their decision to offer a SEC-OND test administration in 2015. The TPED registry exam will be offered on June 20, 2015 in Dallas. The exam is tentatively scheduled to be held in the Embassy Suites Love Field. The FIRST administration will be offered in conjunction with the 2015 TEDA conference. Applications for both test administrations will be due on January 15, 2015. TPED members are encouraged to share this new information with their friends and colleagues who may be considering becoming members of TPED. This decision was made based on feedback and requests from TPED members who have said that they know of people who would like to join the Registry, but who may not be able to attend the TEDA conference. If the second (June) exam administration is successful and draws attendees, the Board has suggested maintaining the third Saturday in June as a second exam administration date. The location for the second exam administration will be determined based on each year's TE-DA conference location. The second exam will be located in a separate, centrally located, location to be determined by the Board each year. We always appreciate feedback and suggestions from our TPED members. We feel that this second test administration will provide TPED with new and exciting growth opportunities. Please help us spread the word! Remember, the application deadline for BOTH 2015 exam administrations is January 15, 2015.
